INTRODUCTION

The right to information is one of the fundamental human rights, and it is guaranteed by Article 34 of the Constitution of the Republic of Moldova. This right cannot be restricted, and public authorities are obliged to ensure correct information to citizens on public matters and matters of personal interest.

The right to information can be provided only by achieving an appropriate level of transparency of public authorities. However, ensuring the transparency in the decision making of a public authority must not become an end in itself. The transparency of decision making, considering the finality it pursues, must ensure that citizens exercise their right to take part in administration, as ruled by Article 39 of the Constitution of the Republic of Moldova. Thus, along with the right to have access to a public function, Moldovan citizens are guaranteed the right to participate in the administration of public affairs directly or through their representatives.

Both the right to information and the right to take part in administration are provided by some important international documents, such as the Universal Declaration of Human Rights (Articles 19 and 21), the International Covenant on Civil and Political Rights (Articles 19 and 25), or Recommendation Rec(2002)2 of the Committee of Ministers of the Council of Europe to member states on access to official documents. At the same time, transparency in decision making is a requirement of many standards, such as those of the European Commission: White Paper on Good Governance; Towards a reinforced culture of consultation and dialogue — proposal on general principles and minimum applicable standards for consultation of the Commission with stakeholders.

Certainly, transparency and accessibility, along with representativeness, accountability and efficiency, are key values that a legislature should guard. A transparent legislature is a legislature that is open to the nation and transparent in its activity. An accessible legislature is a legislature that engages the public into managing the legislative process.

The importance of transparency and accessibility in parliamentary activity is determined by the unique role of legislature in a democracy – to represent their electorate and to be guided by the citizens' needs, interests and ambitions. A legislature can become credible if it is truly transparent and accessible.

Maintaining institutional credibility is becoming a real challenge for the Moldovan Parliament. According to the Barometer of Public Opinion,² there has been a reduction in the citizens' trust in the legislature: in April 2012 – 73% of respondents had not much/no trust in Parliament; in November 2012 – 79.3%; and in April 2013 the degree of mistrust reached 85%.

The credibility problem is related to the perception of the institutional potential of corruptibility. According to the Global Corruption Barometer released by Transparency International in 2010, the Moldovan Parliament is among the institutions increasingly

affected by corruption and obtained a score of 3.7 (on a scale where 1 - not at all corrupt and 5 - extremely corrupt). The same survey, according to the results released in 2013, shows that 75% of respondents in Moldova perceive the Parliament as corrupt/extremely corrupt. 4

The idea that the Parliament, by virtue of its specific functions, unlike the Executive, is under an insignificant risk of corruption, is absolutely erroneous. In fact, Parliament corruption, resulting in corruption of laws, is of a different type than administrative corruption, but equally dangerous, if not the most dangerous, considering its goal and social impact. In the Parliament it means that some groups or individuals, by giving undue advantage to public officers, Members of Parliament or parties in an illegal and obviously non-transparent manner, influence the contents of laws for their own interest and contrary to the public interest. The impact of this phenomenon is devastating, signaling that the state is in captivity.⁵

Moreover, the integrity of the Parliament, judging from its duties (law making, control and appointments), determines the level of integrity of other public authorities. This idea has been exposed in Resolution 1214 (2000) of the Parliamentary Assembly of the Council of Europe, "The role of parliaments in fighting corruption": A parliament is a country's central institution, in its capacity as the primary expression of the people's will, and therefore has a paramount responsibility for combating corruption in all its forms, especially in public life but increasingly also in the economy at large. Parliaments must undertake this task for the general morality of society, but also for its lasting economic progress which vitally depends on honesty and trust.

In fact, corruption exists wherever there is decision-making monopoly and discretionary power; corruption is even greater if there is less responsibility, integrity and transparency.

The formula set out in the UNDP's basic paper on accountability, transparency and integrity is perfectly applicable to the Parliament.

CORRUPTION = (MONOPOLY + DISCRETIONARY POWER) - (ACCOUNTABILITY + INTEGRITY + TRANSPARENCY)

Proceeding from the above, given the practically unlimited monopoly and discretionary power of the Parliament, there is only one way to reduce its vulnerability and increase credibility – by ensuring greater accountability, integrity and transparency.

Parliaments of the world have approached this problem in different ways, but there are some generally accepted practices that have proven themselves in action.⁶

The Moldovan Parliament, too, implements certain mechanisms of cooperation with civil society, and they are subject of research within this study, its aim being the research and evaluation of the practices applied by the Parliament to comply with the legal framework regarding transparency in decision making.

To achieve the goal, the following objectives were pursued:

- Analysis and evaluation of the *Preconditions* that determine the level of transparency of the parliamentary decision making: the legal framework (laws and subordinate legislation) and the institutional framework (actors and mechanisms);
- Evaluation of the level of *Implementation* by the Parliament of the legal provisions on transparency in decision making, with a special view on the transparency of the Parliament's works and working bodies;
- Evaluation of the Finality the Parliament capitalizing on public contributions;
- Formulation of conclusions about the level of transparency in the parliamentary decision making and of recommendations to improve the situation.

The study is focused on evaluating the work of the Parliament between 27 September 2012 and 30 June 2013, thus covering the autumn session of 2012 and the spring session of 2013 (up to 30 June 2013).

The study is multi-aspectual and focuses, given the objectives, on the following indicators: Preconditions, Implementation, and Finality.

To produce the study, the following research methods have been used:

- Analysis of the relevant legal framework through the prism of vulnerability of legal norms and identification of normative deficiencies (ambiguous phrasing, undetermined norms, excessive discretions, lack (insufficiency) of control mechanisms, inadequate accountability and penalties, etc.)
- Monitoring of compliance with the requirements of transparency in the legislative process (submission, registration, examination, adoption of drafts) during the evaluated period, and the synthesis (generalization) of the data obtained;
- Exemplification of shortcomings (failed transparency) by means of case studies (draft laws that were examined and adopted without ensuring decision making transparency);
- Analysis and evaluation of indicators and sub-indicators according to the following reference points:


This research is rather qualitative, providing an overview of the current situation. Some of the main sources used when producing the study are as follows:

- Information placed on the Parliament's website (as of 30 June 2013) is the main source, assuming that the activity of a public authority is transparent precisely to the extent in which a citizen can rely on the information placed in the Internet, if this information is so complete and relevant that people need to make no additional efforts to keep informed (request for information);
- Information relevant to the purpose of the study is contained in the reports (analytical notes) produced by the Secretariat and its subdivisions;
- Policy documents relevant to the purpose of the study and reports on their implementation;
- Researches produced by other national NGOs and relevant to the purpose of the study.

1. Preconditions for ensuring transparency in the decision making of the Moldovan Parliament: legal and institutional framework

The basis of Parliament cooperation with the public has been set in the Concept of Cooperation between the Parliament and Civil Society, approved by Parliament Decision no. 373-XVI of 29.12.2005 (hereinafter – the Concept).

The Concept, in paragraph 3.5, establishes the following forms of cooperation:



Each of the above forms of cooperation has its own methods of organization and conduct, participants and purpose:

Councils of	Created by standing committees, under their jurisdiction, from the representatives of

The actual mechanism of cooperation between the Parliament and civil society has been established by the Permanent Bureau Decision no. 2-XVI of 16.02.2006 on the Execution of Parliament Decision no. 373-XVI of 29.12.2005. In this context, we cannot avoid mentioning

the fact that the above document is not placed on the Parliament's website, thus depriving the public of easier access to the documents relevant to them.

Our expectations regarding increased transparency of the parliamentary decision making upon entry into force of Law no. 239 of 13.11.2008 on Transparency in Decision Making (hereinafter – Law no. 239/2008) certainly seemed more than justified.

In this study, we do not aim to analyze in detail the quality and potential efficiency of Law no. 239/2008. This analysis was performed by several NGOs both at the stage of development and at the stage of monitoring the implementation: Report on the expert analysis of the draft Law on Transparency in Decision Making (Center for the Analysis and Prevention of Corruption)⁷; Monitoring report "Activity of the Moldovan Parliament in 2011" (Association for Participatory Democracy (ADEPT))⁸; Final report on monitoring transparency in decision making (July-December 2011) (ADEPT)⁹; Annual monitoring report "Access to Information and Transparency in Decision Making" – 2010 (Acces-Info Center)¹⁰; Annual monitoring report "Access to Information and Transparency in Decision Making: evolution and … inertia" – 2011 (Acces-Info Center)¹¹.

However, we cannot overlook the essential delays in the enforcement of legal provisions, which are becoming traditional. Although the Government should have prepared and adopted the acts necessary to implement the law within 3 months since publication, 05 December 2008, it happened much later, by Government Decision no. 96 of 16.02.2010 on Implementation of Law no. 239-XVI of 13 November 2008 on Transparency in Decision Making. The same observation applies to the Parliament. Exceeding the deadline, Parliament Regulations adopted by Law no. 797 of 02.04.1996 (hereinafter – Parliament Regulations) were supplemented by Law no. 72 of 04.05.2010 in order to implement Article 13 (4) of Law no. 239/2008. Amendments particularly refer to the organization of public consultations by the standing committee informed of the matter (Article 49¹ of Parliament Regulations). However, they are so general that they leave basic rules at the discretion of committees and fail to bring a qualitative change.

More clarity in terms of ensuring transparency in decision making is provided by the Instruction on the Circulation of Draft Legislation in Parliament, approved by the Permanent Bureau Decision no. 30 of 07.11.2012, entered into force on 01 January 2013 (hereinafter – Instruction).

The Instruction, proceeding from the object of regulation stated in item 1.1.2, establishes the rules governing the procedure and requirements of registration, distribution and examination of draft legislation in the working bodies of the Parliament and in the subdivisions of the Parliament Secretariat (approval of drafts), as well as the rules governing the preparation of draft legislation for debates in the plenum of the Parliament (preparation of reports, editing and preparation of final texts of draft legislation), signing of the adopted legislation and its submission for promulgation, review of the legislation that was not promulgated by the President of Moldova and returned to the Parliament.



Schematically, the circuit of draft legislation includes several distinct stages.

The public can contribute to decision making from the moment when drafts are placed on the Parliament's website and during public consultations, if any are conducted:



It should be mentioned that the Instruction, in items 2.1.3-2.1.4, expressly and exhaustively prescribes the compulsory documents required to submit a draft, as well as the documents of the file accompanying the draft, which shall be placed on the Parliament's website:

Legal expert opinion, as part of the Government conclusion; Anticorruption expert opinion, in accordance with the resolution of the President of Parliament.

For an initiative of the President of the Republic of Moldova

Address for submission of the legislative initiative, signed by the President of the Republic of Moldova;

Copy of the Government decision on approval of the draft legislative act, along with its translation into the Russian language (depending on the type of the draft legislative act); Draft legislative act, along with its translation into the Russian language;

Explanatory note to the draft legislative act, along with its translation into the Russian language;

Legal expert opinion and anticorruption expert opinion.

For an initiative of the People's Assembly of Gagauzia

Address for submission of the legislative initiative, signed by the President of the People's Assembly of Gagauzia;

Decision of the People's Assembly of Gagauzia on adoption of the draft legislative act;

Draft legislative act, along with its translation into the Russian language;

Explanatory note to the draft legislative act, along with its translation into the Russian language;

Legal expert opinion and anticorruption expert opinion.

Act that served as basis for initiating the drafting of the legislative act; Conclusions of the national authorities and institutions concerned:

Summary of recommendations received during public consultation as required by Law no. 239-XVI of 13 November 2008 on Transparency in Decision Making;

Results of legal, anticorruption, economic, financial, scientific, environmental, linguistic and other expert opinions, if produced while drafting the legislative act. The legal and anticorruption expert opinions are compulsory for all draft legislative acts;

List of documents that need to be developed or reviewed in connection with the adoption of the legislative act;

Table of Concordance, providing the compatibility of the draft legislative act with the Community legislation, prepared in accordance with Government Decision no. 1345 of 24 November 2006 on the Approximation of the Moldovan Legislation with the Community Legislation, and the declaration of compatibility of the draft legislative act, issued according to Government Decision no. 190 of 21 February 2007 on Establishing the Center for Approximation of Legislation.

The Instruction is also valuable by the fact that it contains, in item 2.1.7, special provisions regarding drafts of individual decisions and other decisions that do not contain legal norms, and also certain additional documents for the initiatives of designation or appointment of candidates for certain positions, as well as additional documents for the initiatives of establishment of the Parliament's working bodies:

The Instruction, however, is not so detailed in the part regarding public consultation. Norms are reduced to a repetition, in items 3.6.1-3.6.3, of the competences of the standing committee informed of the matter and of organization of public consultation procedures, making general references to Parliament Regulations, Law no. 239/2008, the Concept, Permanent Bureau Decision no. 2-XVI of 16.02.2006 on the Execution of Parliament Decision no. 373-XVI of 29 December 2005.

Thus, the norms covering the organization and conduct of public consultations are still too general to be explicit and applicable, and as a result – provisions are not implemented or are implemented unevenly and inefficiently.

The same finding is also applicable for the provisions regarding the institutional framework aimed to ensure transparency in the parliamentary decision making. The norms, dispersed across a number of documents, evidently reduce the potential effectiveness of key actors.

Given the legal provisions of the above-mentioned regulatory documents and considering them in connection with the ones contained in the Regulations of Organization and Operation of the Parliament Secretariat, approved by Permanent Bureau Decision no. 31 of 12.12.2012 (hereinafter – Regulations), transparency in the Parliament's decision making is ensured by the following institutional framework:

General Department of Information and Analysis - Ensures the transparency of the legislative process and development of mechanisms for the cooperation between the Parliament and civil society, including by the following measures: producing studies of information, analysis and synthesis that are necessary for the internal and external parliamentary work; ensuring the transparency of the legislative process and monitoring the process of communication between the Parliament and civil society; ensuring the functionality and development of the Integrated Information Space and of the Parliament's website (Article 20 of Regulations); - Ensures placement on the Parliament's website of the information about the internal rules covering the procedures of informing, consulting and participating in the examination and adoption of legislative acts; the drafts of legislative acts and materials related to them; the results of public consultations (minutes of consultative public meetings, synthesis of recommendations); and other information (item 3.6.4 of the Instruction); - Constantly updates on the Parliament's website the information regarding the draft legislative acts introduced into the legislative procedure (item 2.2.22 of the Instruction).

Overall, the current legislation establishes a certain framework, including institutional, aimed to ensure transparency in parliamentary decision making. However, it has some weaknesses that need to be overcome. The table below contains the identified weaknesses, objections regarding some provisions, as well as recommendations related to improving legal norms¹²:

Firstly, it should be noted that both the acts of concealment and distortion require proof of intent, which is difficult to obtain. However, in order to truly increase the efficiency of decision making within public authorities, one should equally monitor the following aspects: failure to inform the public about the initiation of decision making; failure to allow the access of stakeholders to the draft decision and to related materials; failure to consult; failure to examine recommendations; failure to inform the public about the conduct of a public meeting; failure to inform the public about the adopted decisions; failure to prepare or inadequate preparation and failure to publish reports on transparency in decision making.

Secondly, the norms are confusing in terms of legal action against the acts or decisions of public authorities that are made in violation of Law no. 239/2008.

The only applicable sanction, under the existing norms, could be exclusively a disciplinary sanction. To assess the potential effectiveness of the mechanism aimed at sanctioning violations of legal provisions, one usually analyzes the statistics on the sanctions applied. Given the fact that the Parliament does not provide such statistics, we shall refer to the information provided by the State Chancellery, which has the mission to monitor compliance with the provisions on transparency in the decision making of the central specialized authorities. 2. Implementation by the Moldovan Parliament of legal provisions on transparency in decision making

2.1. Transparency in the Parliament's works

Parliament sessions and meetings

According to the Review of the works of the 19th Parliament during the spring and summer sessions of 2012¹⁴, 27 meetings were held during the autumn session, including:

The Parliament's website contains the agendas and transcripts of all plenary meetings, except the meetings of 21.06.2013, 27.06.2013 and 28.06.2013, for which transcripts are unavailable.

The website contains no video or audio recordings of the meetings. It should be mentioned that practically all Parliament meetings could be watched live on the website www.privesc.eu. However, it would be preferable for the Parliament's website to allow

viewing and audition, including online, of Parliament meetings. Thus, the Parliament and the public would not depend on the agenda of a private media outlet.

Legislative procedure

For the period 27.09.2012-31.12.2012, the Parliament's website contained 181 registered drafts, and 102 of them had the status of adopted drafts (Annex 1 to this study).


Out of the 102 adopted drafts, 63 (62%) drafts were initiated by Members of Parliament (one MP or a group of MPs), 30 (29%) – by the Government, and 9 (9%) – by the President of the Republic of Moldova.

Out of the 102 adopted drafts, 66 (65%) are draft laws and 36 (35%) – draft Parliament decisions.


Only for 5 (5%) drafts out of the 102 adopted we have found availability of all additional documents announced online, considering that the web file for each draft is prepared on the basis of a resolution of the President of Parliament regarding the draft. This number, however, would be smaller if we applied the legal requirements in terms of documents that must necessarily accompany a draft. The gravest deficiency is the absence of syntheses of proposals and amendments. We should also mention the absence of CVs in case of drafts concerning appointments. It is unclear whether the persons proposed for appointment had been verified according to Law no. 271 of 18.12.2008 on Verification of Public Officers and Candidates to Public Offices. Overall, for this period a single CV is available, and the syntheses accompanying the reports of the standing committees informed of the matter are available for 5 drafts only.

For the other 97 drafts, considering their specificity (regulatory/non-regulatory nature), we have found the following deficiencies:

- Unavailability of conclusions of committees (including one or several committees) for 74 drafts;
- Unavailability of the draft text in the Russian language for 48 drafts;
- Unavailability of Government conclusion for 29 drafts;
- Unavailability of the conclusion of the Legal Department of the Parliament Secretariat for 11 drafts;
- Unavailability of the report of the standing committee informed of the matter for 9 drafts:
- Unavailability of the explanatory note for 8 drafts;
- Unavailability of the final version of the drafts for 4 drafts.



Regarding the deadlines for the public consultation of drafts, it should be noted that out of the 102 adopted drafts, the permanent deadline for consultation (15 working days) was missed for 65 drafts¹⁸, 4 of which were debated and adopted on the day of registration and 4 – on the calendar day following registration.



For the period of 01.01.2013-30.06.2013 the Parliament's website contained 284 registered drafts, and 119 of them had the status of adopted drafts (Annex 2 to this study). The Parliament's website lacked 5 drafts (no. 281 and nos. 283-286).

Out of the 119 adopted drafts, 91 (76%) drafts were initiated by Members of Parliament (one MP or a group of MPs), 21 (18%) – by the Government, and 7 (6%) – by the President of the Republic of Moldova.



Out of the 119 adopted drafts, 64 (54%) were draft laws, 54 (45%) – draft Parliament decisions, and 1 (1%) – a vote.

Only for 11 (9%) drafts out of 119 we have found availability of all additional documents announced online, considering that the web file for each draft is prepared on the basis of a resolution of the President of Parliament regarding the draft. This number, however, would be smaller if we applied legal requirements, with deficiencies similar to the ones found for the previous period. Overall for this period: 2 CVs are available; the synthesis of proposals and objections is attached to 3 explanatory notes produced by direct authors; only 4 drafts, except the ones initiated by the President¹⁹, were accompanied by the ministries' conclusions; only 6 drafts were accompanied by a synthesis of proposals and amendments attached to the reports of standing committees informed of the matter; a single draft was accompanied by an impact analysis.

As for the other 108 drafts, given their specificity (regulatory/non-regulatory), we have found the following deficiencies:


- Unavailability of conclusions of committees (including one or several committees) for 63 drafts;
- Unavailability of the Government conclusion 37 drafts;
- Unavailability of the report of the standing committee informed of the matter 36 drafts;
- Unavailability of the text of the draft in the Russian language 33 drafts;
- Unavailability of the final version of the draft 23 drafts;
- Unavailability of the conclusion of the General Legal Department of the Parliament Secretariat – 17 drafts;
- Unavailability of the explanatory note 13 drafts;
- Unavailability of the report on anticorruption expert opinion 11 drafts;
- Unavailability of the text of the draft 1 draft.

During the spring session 2013 there were also clear violations of the deadlines for consulting of drafts. Out of the 119 adopted drafts, the permanent deadline for consultation (15 working days) had been missed for 83 drafts, 17 of which were debated and adopted on the day of registration and 12 – on the day following registration.



In addition, it should be mentioned that one of the major deficiencies was the unavailability of the Government's conclusion on the drafts of documents approving the budgets of some authorities. At the same time, it is regrettable that the Parliament is not sufficiently insistent in its function of control. For example, for the draft Decision of the Court of Accounts on the Administration and Use of Public Funds and Public Property in 2011, only the text of the draft was available, while all other documents, including the Report of the Court of Accounts, were missing. Moreover, the Parliament's website contained a single report (a link to the website of the relevant authority) – the Report on the Activity of the Broadcasting Coordinating Council in 2012²⁰.

The voting procedure

According to the Report on the Implementation in 2012 of the Strategic Development Plan of the Parliament Secretariat for 2012-2014²¹, a number of activities were performed aimed at developing the Parliament's infrastructure, namely: reorganization of the Secretariat and restructuring of the institutions subordinated to the Parliament through liquidation of subordinated public institutions, namely the Department for the Maintenance of Parliament Buildings, the Parliament's Car Fleet, and the state enterprise of public catering "Cafeteria of the Parliament of the Republic of Moldova"; assessment of needs in the IT equipment and in provision of the Parliament with IT equipment; development of the concept "Digital Archive of the Parliament of the Republic of Moldova" Information System.

The action plan for the implementation of the Strategic Development Plan of the Parliament Secretariat for 2013²², approved by Permanent Bureau Decision no. 8 of 27.03.2013, provides for the realization of a number of activities related to the development of the Parliament infrastructure, including electronic registration of the MPs presence at plenary meetings and implementation of electronic voting. Performance indicators established for the above are installation and application of the electronic registration and electronic voting systems and personnel training (after reconstruction of the Parliament building).

By the end of 2013 there could be significant delays in the realization of these important works. The constraint that the Parliament faces is clear – delays in the reconstruction of the Parliament building. However, it should be noted that such delays could affect the image of the Parliament: if the Parliament cannot manage its direct constraints, one cannot expect for it to be able to manage constraints at country level.

While the absence of electronic registration of the MPs' presence at plenary meetings is partially compensated by transcripts of the meetings and by statistically generalized information (Statistic Report on the MP's Attendance of the Parliament's Plenary Meetings in 2012²³; Statistic Report on the MP's Attendance of the Parliament's Plenary Meetings (September-December 2012)²⁴), then the implementation of electronic voting is becoming a necessity.

The current voting procedures not only discourage the public in their attempt to monitor their elected representatives; they can also tempt Members of Parliament to unjustifiably reexamine (revoke) acts that have already been adopted and entered into force. An eloquent example in this regard is Parliament Decision no. 104 of 03.05.2013 on Nullifying Parliament Decision no. 81 of 18.04.2013 on the Appointment of Prosecutor General. Subsequently, Parliament Decision no. 104 of 03.05.2013 was declared unconstitutional by Decision of the Constitutinal Court no. 8 of 20.05.2013.

Thus, accelerating the reconstruction of the Parliament building would be a priority, which would demonstrate the real willingness of the Parliament to develop its infrastructure in order to increase its transparency.

2.2. Transparency in the activity of the Parliament's working bodies

Permanent Bureau

The Permanent Bureau appears to be the least transparent working body of the Parliament. It is natural for it to enjoy greater confidentiality in its works. However, it seems insufficient to place on the Parliament's website only the composition of the Permanent Bureau and the announcements about its meetings. The public needs to be informed, however briefly, about its agenda, with all decisions of the Permanent Bureau being subsequently placed on the Parliament's website. It would increase the credibility of this body by confirming that its activity is governed not only by party interests, but also by the general public interest.

Standing parliamentary committees

According to the statistics on the number of meetings of the Parliament's standing committees²⁵, 150 meetings took place in the autumn session of 2012.

The agendas of all meetings are placed on the Parliament's website²⁶, and it is actually the only information about the work of the committees available to the public.

For the period 01.01.2013-30.06.2013, the agendas of 228 committee meetings were placed on the Parliament's website.²⁷ It is regrettable that the minutes of committee meetings remain unavailable, since the public is interested not only in the issues examined by a committee, but also how decisions were made.

We shall remind about the competence of standing committees according to Article 27 (4) of Parliament Regulations, i.e. the competence of preparing the list of stakeholders. The current list of stakeholders was produced in 2011 and is placed on the Parliament's website.²⁸ The list was last updated on 22 May 2013. It is systematized by areas of activity of the standing parliamentary committees.

At the same time, the Parliament's website contains the list of consultants working within standing committees and responsible for keeping registers of contributions received from

the civil society and of cooperation events held at committee level in order to monitor the implementation of the Concept of Cooperation between the Parliament and the Civil Society and of the Decision on the Execution of Parliament Decision no. 373-XVI of 29 December 2005 according to the President of Parliament Directive DD/C-1 no. 32 of 31 March 2010.²⁹

However, committees do not seem quite interested in public consultations. The Parliament's website contains 13 announcements about the organization of public consultations, and only 5 of them were initiated by standing committees, while the others were initiated as follows: Members of Parliament – 5 announcements, special committee – 1, parliamentary group – 1, President of Parliament – 1.

Regarding the public consultation announcements, we have found as follows:

- They are placed in the News section, thus being lost among announcement about the protocol agenda and participation of officials in various events (seminars, flowerlaying ceremonies, etc.);
- The period between publication of announcements and the dates of events is too short to encourage the public to contribute to drafts. It is obvious that when an event is scheduled for the day immediately following its announcement, consultation is compromised;
- The terminology used to define the methods of consultation is confusing. For example, the contribution expected from the public at the meeting of a working group (to assist or to participate) is unclear;
- The name of the person directly responsible for the event is not indicated except in one case – request for contributions in the process of development of the Concept of Reform of the Prosecutor's Office. It should be mentioned that in this case the request of "some useful contributions" is discouraging, since the public and the initiator may have different views on the usefulness of contributions, while this fact should not discourage a dialogue that has not even started yet.

At the same time, it should be mentioned that the website contains no records of the stakeholders' contribution or information about the councils of experts. Standing

parliamentary committees seem to be uninterested in this mechanism of cooperation with the civil society.

3. Capitalization on public contributions by the Moldovan Parliament

The value of transparency in the decision making of a public authority is as great as the extent of public participation in decision making. The more credible the authority, the more actively the public participates in decision making. Clearly, the credibility of an authority is little if it fails to respond to public contributions, to analyze the incoming proposals or communicate their finality (whether they have or not been accepted, and if not accepted – for what reasons), to generalize or communicate statistics relevant to decision making.

The information provided by the Parliament about the methods of capitalization on public contributions is modest. It is practically non-existent even on occasion of annual conferences titled "Cooperation between the Parliament and Civil Society." In fact, the Parliament's website contains information only about the conference of 13.04.2010³⁰ (participants and agenda) and the conference of 11.05.2011³¹ (participants, agenda, transcript and synthesis of the issues covered).

The Parliament's website contains only one report, produced in 2010, that attempted to analyze civil society contributions — Report on the Contributions of Civil Society Representatives and Cooperation Events within the Standing Committees of the Parliament of the Republic of Moldova³², prepared according to the President of Parliament Directive DD/C-1 no. 32 of 31.03.2010 and the Concept of Cooperation between the Parliament and Civil Society no. 373-XVI of 29.12.2005. Although this report cannot be considered analytical, its usefulness is indisputable.

For other periods, some information in this regard can be found scattered among a variety of documents.

For example, according to the Report on Examination of Petitions Addressed to the Moldovan Parliament in the Period 01.01.2012-31.12.2012,³³ in 2012 the Parliament received 192 petitions with citizens' proposals on amending legislation (29 petitions less than in 2011). The Report concludes that such petitions are generated by uneven application of the legislation, arbitrary interpretation of legal norms, suspicions of inconsistency of some legislative acts with the Constitution, or intention to obtain some benefits in various fields. The Report, however, does not provide information about finality – whether these proposals were or not set in motion.

Another document in this regard is the Report on the Activity of the Parliament Secretariat between 01 January and 31 December 2012³⁴. The Report outlines the actions taken to increase the efficiency of communication between the Parliament and the civil society, indicating that efforts were mainly concentrated on the implementation of the Parliament Communication Strategy for 2011-2014 in the following areas: development of the concept of Parliament Newsletter for central and local public authorities, civil society and

development partners; consolidation of the communication system by establishing the Department of Communication and Public Relations; development of the concept of Visitors and Information Center; development of the concept of Media Center. The Report, however, does not analyze the progress of communication: whether the public participation in the Parliament's activity increased or not, how many public consultation events were organized and conducted, and how useful they were.

The Report on the Implementation in 2012 of the Strategic Development Plan of the Parliament Secretariat for 2012-2014³⁵ is also deficient in this regard, as it contains only some mentions about the actions performed: organization of 7 political forums in various places of the country by the Parliament's Foreign Affairs and European Integration Committee and development of a Public Hearings Guide that shall be submitted for examination and approval to the Permanent Bureau along with the related draft law. The Report also indicates some actions that are still to be implemented in order to increase interaction between Members of Parliament, citizens and the civil society, such as the execution of the Public Hearings Guide. Thus, standing committees will organize public hearings on various issues (legislation and parliamentary control) in order to collect information from citizens and civil society and provide a platform for dialogue. At the same time, there are plans to elaborate procedures for the use of modern electronic communication tools (electronic consultation about legislation, policies, online discussions) and to create 4 territorial offices for Members of Parliament and their personnel, which would serve as information and public access outlets aimed at raising citizens' awareness about the democratic role of the Parliament and as territories for decentralized meetings of standing committees and outlets of civic education and citizen participation, including in election processes. This Report does not, however, provide information similar to the one required by the law for the Report on Transparency in Decision Making.

Public contributions cannot practically be monitored. Thus, for the reported period, some mentions in this regard are contained in the additional documents attached to 3 drafts³⁶, all of them registered and examined between 27.09.2012 and 31.12.2012:

				mentioning civil society proposals, without providing rationale for their non-acceptance.

Besides the fact that such cases are not numerous, since mentions about public contributions are exceptions rather than a custom, the following shall be pointed out:

- Mentions about public participation in decision making are general and give no details in this regard;
- Although the representatives of some NGOs are mentioned in the synthesis attached to the report of the standing committee, no arguments are given to justify the non-acceptance of their proposals.

In fact, the Parliament only worked on the subject of transparency a single time, when it was covered in the Report of the Special Committee for the Examination of the Impact of Law no. 94 of 19.04.2013 on the Modification and Supplementation of Some Legislative Acts (hereinafter – Law no. 94/2013), a committee created by Parliament Decision no. 97 of 25.04.2013.

Law no. 94/2013 was adopted on the basis of draft Law no. 163 of 16.04.2013 on the Modification and Supplementation of Some Legislative Acts (Elections Code – Articles 1, 4, 10, 13, 22, 27, 39, 42, 46, 48, 53, Title III; Law on the Status of Member of Parliament – Articles 2, 3), submitted as a legislative initiative by a group of Members of Parliament. The draft law, registered on 16.04.2013, was given a conclusion by the Social Protection, Health and Family Committee and by the standing committee informed of the matter, i.e. the Legal, Appointments and Immunities Committee (report for the first reading), and included by the Permanent Bureau on the agenda of the plenary meetings of 18-19 April 2013. On 18.04.2013, draft no. 163 of 16.04.2013 was adopted by the Parliament in the first reading, and on 19 April 2013, on the basis of the report of the standing committee informed of the matter that it prepared for the second reading, the Parliament adopted the draft in the second reading and forwarded it for promulgation to the President of the Republic of Moldova. On 20.04.2013 the draft was promulgated and published in the Official Monitor.

Having analyzed the above circumstances, the Special Committee concluded as follows:

• The procedure of adoption of the draft was conducted in violation of legal and regulatory conditions of the legislative technique. It was also accompanied by the failure to submit the conclusions of standing committees (which had to be submitted within 30 days), the anticorruption, economic and financial expert opinions, the consultative conclusion of the Central Election Commission, the expert opinions of international institutions (the Council of Europe, the Venice Commission), and by the failure to discuss the draft with the civil society, as it is prescribed by Parliament Regulations, Law no. 780 of 27.11.2001 on Legislative Acts, Law no. 239 of 13.11.2008 on Transparency in Decision Making, Instruction for the Circulation of Draft Legislative Acts in the Parliament, approved by the Permanent Bureau Decision no. 30 of 07.11.2012, etc.;

- The Law was adopted without the agreement and/or positive conclusion of the Government, meaning that it is unconstitutional in the context of the Constitutional Court's case law (Constitutional Court Decision no. 5 of 18.02.2011), since the discussions held at the Central Election Commission revealed that in a mixed electoral system the expenses on the organization of elections would increase with about MDL 15 million;
- The draft was not placed on the Parliament's website as prescribed by Article 48 (2) of Parliament Regulations, which is a failure to comply with the principle of transparency in decision making;
- The Permanent Bureau decided to include the draft into the agenda without taking into consideration the conditions of Article 57 (2) of Parliament Regulations, which prescribes that at the meeting of the Permanent Bureau examining the issue of inclusion of a draft legislative act into the agenda, the standing committee informed of the matter shall present: a) the goals, tasks and concept of the draft, the forecast of its social, economic and other effects, and the category of the law; b) the list of authors that participated in preparing the draft; c) the list of persons or organizations that provided expert opinions regarding the draft; d) the economic and financial substantiation of the draft; e) the conclusion of the standing committee (committees) regarding the draft; e) the results of public consultation of the draft; f) the conclusion of the Legal Department of the Parliament Secretariat (submitted on 19.04.2013); g) the list and/or, as applicable, drafts of legislative or regulatory acts necessary in order to execute the adopted legislative act;
- The deliberation of the draft law in the first and second reading failed to observe the Members' of Parliament rights to propose amendments, according to Articles 59 and 65 (2) of Parliament Regulations and Article 19 of Law no. 39 of 07.04.1994 on the Status of Member of Parliament;
- As for the Members' of Parliament right to propose amendments, which is correlative and in direct connection with the right to forward legislative initiatives, prescribed by the Constitution and confirmed by the case law of the Constitutional Court (Constitutional Court Decision no. 15 of 04.12.2012), the President of Parliament, who presided at the plenary meetings of 18-19 April 2013, failed to take into consideration the request of a parliamentary group to solicit the expert opinion of international institutions or to observe the Members' of Parliament rights to propose amendments under the terms and conditions prescribed by legal and procedural norms or to submit these requests and proposals of the opposition to vote, having taken the unilateral decision of ignoring them. As a consequence, the Members' of Parliament rights were disregarded.

The Special Committee's Report, when addressing the public consultations with the representatives of NGOs specialized in constitutional and electoral law conducted on 29.04.2013, concluded as follows:

- Law no. 94/2013 can be subject of some objections regarding its inconsistency with the Constitution in terms of the procedure of its adoption and failure to observe the fundamental and legal rights of citizens to elect their representatives;
- The process of approval of the Law was seriously deficient, and as such it could not create a good law. It is also confirmed by the fact that the approval of the law was followed by a search for solutions, which should have been done before approving the law, and not after it. The discussions surrounding this situation confirm that

- approval of the law led to a number of problems, while its benefits are unclear at the moment;
- The Law fails to ensure equal access of all voters to the exercise of the right to vote, which is particularly true for the citizens residing in Transnistria and abroad;
- The modifications introduced by Law no. 94/2013 considerably increase the costs related to elections, which is unacceptable in the current economic situation.

In the end, the Special Committee recommended the Parliament to repeal Law no. 94/2013.

The findings and conclusions of the Special Committee are mainly unquestionable. It might seem that the Parliament is very seriously concerned with ensuring transparency in the legislative decision making. A single fact proves otherwise – there is a significant amount of drafts examined and adopted by the Parliament in violation of legal provisions on transparency and on the legislative technique. Even more discouraging is the fact that on 03.05.2013, the day of submission of the report to the plenary meeting, other 9 drafts were debated and adopted:

All these drafts were adopted in violation of the term set for permanent consultation with the civil society. They all have deficiencies similar to those found for Law no. 94/2013 (lack of the report of the standing committee informed of the matter; lack of conclusions of committees; lack of the conclusion of the General Legal Department of the Parliament Secretariat; lack of Government conclusion; lack of the report on anticorruption expert opinion). The legislative framework applied is even worse. Some of these drafts provide conflicting interventions for the previously modified and supplemented prescriptions, some of them only several weeks apart. It is true, however, that the previous intervention also violated procedures. Such practices undermine the essential elements of a state of law: stability of regulations, security of legal relations, and predictability of law.

CONCLUSIONS AND RECOMMENDATIONS

The observation and analysis of the current situation led to the following conclusions and recommendations:

- 1) Overall, it is essential to improve Law no. 239 of 13.11.2008 on Transparency in Decision Making in the parts relating to violations and sanctions. The lack of violations identified and sanctions applied by authorities, despite the findings of the monitoring performed by NGOs, is indicative of the inefficiency of the Law in this regard.
- 2) Particularly, given the specificity of Parliament functions, transparency in decision making required a more comprehensive intervention into Parliament Regulations adopted by Law no. 797 of 02.04.1996. The current version of Parliament Regulations contains only norms that attribute to standing committees the competence to set certain rules. This approach is dangerous for two reasons: i) standing committees may avoid or delay exercising their competence; ii) even if standing committees set certain procedures, they could be different among committees or drafts. Thus, non-uniform and selective practices can be established, discouraging public participation in parliamentary decision making. The rules of consultation between the public and the Parliament should be simple and clear. Parliament Regulations need to at least contain some beginnings of procedures that would be uniformly applicable by all committees for all drafts subjected to public consultation. Considering the above, we insist in this regard on the need to review Parliament Regulations in the parts relating to the excessive discretion of the President of Parliament, who at the moment has the power to make decisions, including decisions on extending terms, while no clear criteria have been set to serve as basis for such decisions. The same recommendation is applicable for some norms in the Instruction on the Circulation of Drafts of Legislative Acts within the Parliament, approved by the Permanent Bureau Decision no. 30 of 07.11.2012.
- 3) While we appreciate the effort of the Parliament Secretariat in the elaboration of the Instruction on the Circulation of Draft Legislative Acts within the Parliament, we find it regrettable that this act is not more explicit in terms of organization and conduct of public consultations. In fact, the rules ensuring the transparency in parliamentary decision making are currently dispersed among a number of regulatory acts. Thus, procedures remain confusing and difficult to apply. It is necessary to supplement Parliament Regulations with systematized comprehensive provisions aimed at ensuring transparency or systematization of all norms in a separate regulatory document, eventual Regulations on Ensuring Transparency in Parliamentary Decision Making. Such provisions should regulate the forms and procedures of public consultations; reception, analysis and synthesis of recommendations; production and publication of a report on transparency in decision making; responsibilities of key actors; an exhaustive list of documents that need to be placed online, including the ones covering the activity of parliamentary groups, the Permanent Bureau and standing committees; clear terms; control mechanisms; etc.
- 4) The "Civil Society" section of the Parliament's website should be, in our opinion, redesigned into the section "Transparency in Decision Making." This section should be truly useful and friendly to the public, and it should contain: the rules regarding transparency in parliamentary decision making; an outline of the mechanism of cooperation with the civil society, including procedures that need to be followed by stakeholders; responsible

persons; a list of stakeholders; announcements about public consultations; records of the contributions of stakeholders; information about annual conferences; reports on transparency in decision making; etc.

- 5) In terms of transparency of Parliament's sessions and meetings, while we appreciate the Parliament's efforts of placing the agendas and transcripts on its website, we should mention the need of placing the video/audio records of meetings there as well. It would be preferable for the Parliament's website to allow viewing of and listening to plenary meetings, including online. Thus, the public and the Parliament would not depend on the media agenda of a private company.
- 6) As for the voting procedure, the electronic registration of the Members' of Parliament attendance of plenary meetings and the implementation of electronic voting should be a priority, since they become important not only for the public, who needs to know how a certain Member of Parliament voted, but also for Members of Parliament, who need to have the proof of a vote exercised.
- 7) In terms of transparency of the legislative procedure, we appreciate the efforts of placing drafts on the Parliament's website. We shall also mention the importance of facilitating the knowledge of the dates of placement. At the same time, we shall remind about the great amount of unavailable documents: conclusions of committees; conclusions of the Government; conclusions of the General Legal Department of Parliament Secretariat; reports of standing committees informed of the matter; explanatory notes; other required documents. These deficiencies, however, are determined by the celerity with which the Parliament uses to examine drafts, which is not always justified.
- 8) A separate problem that needs to be overcome consists in the practices of appointment and dismissal. In addition to the fact that drafts do not contain all the necessary accompanying documents, such as the person's CV, the available information does not make it clear whether the persons in question were or were not verified according to Law no. 271 of 18.12.2008 on the Verification of Public Officers and Candidates to Public Offices.
- 9) As for the transparency of the Parliament's working bodies, the Permanent Bureau appears to be the least transparent. The public needs to be informed, however briefly, about the agenda of the Permanent Bureau. All decisions of the Permanent Bureau, especially the ones concerning the public interest, need to be placed on the Parliament's website.
- 10) We appreciate the placement on the Parliament's website of agendas of standing committees. However, we insist on the need to place the minutes of the committees' public meetings there, too.
- 11) It is regrettable that the Parliament's website contains no information about the creation of councils of experts by standing committees. This tool could increase the quality of the debated draft documents.
- 12) The standing committees fail to capitalize on the public contributions in the reports that they produce on draft documents. These reports must necessarily contain mentions regarding transparency in decision making. If a draft is not subjected to public consultation,

this fact should be mentioned and justified. The lack of any contributions should also be mentioned. The refusal to accept the proposals received from the public, including NGOs, should be supported by arguments.

- 13) We appreciate the announcement of public consultations on some draft laws. However, announcements are still too rare to convince us of having become a truly established practice. We insist that events need to be announced earlier than it is customary, thus offering the public a real opportunity to participate in decision making. At the same time, we shall mention that the website shall contain the records of the stakeholders' contribution.
- 14) The efforts of the Parliament Secretariat in the elaboration of some policy papers shall be acknowledged, but they (or at least a summary of them) should be found on the Parliament's website.
- 15) We appreciate the efforts of the Parliament's Secretariat in preparing its activity reports and in implementation of policy papers. These reports, however, do not compensate the lack of annual reports on transparency in decision making, which could prove to the public that their contributions to the Parliament were at least examined, if not accepted. At the same time, it would be advisable to prepare comprehensive analytical reports, by the end of the year or the end of session, covering the Parliament's activity in the exercise of its functions, including the function of control.
- 16) The Parliament's commitment to observe the procedures of transparency in decision making while examining and adopting Law no. 94 of 19.04.2013 on the Modification and Supplementation of Some Legislative Acts was important. It is, however, regrettable that it was a single and selective instance, and the conclusions of the Special Committee failed to contribute to a more qualitative approach to the legislative process. We shall remind about the alarming amount of drafts examined in violation of the term set for permanent consultation. Even more alarming, though, is the even greater amount of drafts debated and adopted on the same day or on the calendar day immediately following registration. This fact not only discourages the public, but also disrupts the entire legislative process. Thus, not only the public, but also the Members of Parliament, standing committees, Parliament Secretariat (General Legal Department), and the Government are deprived of the possibility to share their opinions on drafts in advance. The celerity of the legislative process is indicative of major problems in the administration of the legislative process. A flagrant, grave and repeated violation of legislative procedures erodes public confidence in the good will of the legislature, which seems to be guided by other interests than the public interest, while the latter consists in a legitimate, balanced, coherent, consistent and transparent legislative process. Laws need to be drafted thoroughly, with expenses calculated and covered, with a previously estimated impact, based on real and realizable needs, subjected to public consultation and beneficial to the public, meticulously examined by the Parliament, exposed to qualitative debates and conscientious voting.
